General Notes

The Scottish Mountaineering Trust is from time to time able to provide financial assistance to projects having relevance to the mountainous regions of Scotland and elsewhere. All applications are considered on their individual merits but Trustees will generally apply the following rules.

Grants are normally made subject to all other project funding being in place and that a definite time for the commencement of the project has been agreed. Funds are not provided unduly in advance and the project must not vary from that outlined in the application. It is a requirement of the Trust maintaining its charitable status that any application must also have a declared and patent educational or scientific purpose.

In the case of improvements to climbing huts, it is a stipulation that the hut has to be made available to the general mountaineering public as evidenced by an appropriate entry on the MCofS / BMC list.

While projects outwith Scotland are eligible, Trustees will normally expect a clear and relevant Scottish connection in order for such applications to be considered.

Where a grant is made, the Trust requests acknowledgement of its support in any publicly printed material. The Trust reserves the right to attach such conditions to any grant as may be deemed appropriate.

Where a project is cancelled any monies advanced by the Trust must be refunded without undue delay.

All grants will lapse if not taken up within a period of two years of the Trustees' Meeting awarding the grant.
